EQUIPMENT TERMS & CONDITIONS

PAYMENT: Payment is required for equipment at the time of purchase. Orders will be put into production only after receipt of payment, not purchase order. Orders for larger ovens (bench top & 2' w ovens not included) can pay a 50% deposit up front. The remaining balance must be paid 2 weeks prior to shipping. Due to shorter production time, full payment for booths and small systems is required when the order is placed.

We accept the following payments:

• ACH Payment - No processing fee for customer. Please contact Columbia Coatings customer service for instructions.

• Wire Transfer - Charges may occur at your local bank. Please contact Columbia Coatings customer service for instructions.

• Credit Cards – 1.5% processing fee added to your order for Visa/MasterCard - 3.0% processing fee added to your order for American Express/Discover. This fee is not calculated online. Customers placing equipment orders online will be contacted by a sales associate.

• Checks – Checks can only be accepted on the first payment. If you want your entire transaction paid via check, then it is required to pay 100% when you order the system. All returned checks will be charged \$20

• Lease – Visit our home page (www.columbiacoatings.com) and go to the financing section to fill out an application from Centra Funding. We will also work with a finance company of your choosing.

LARGE OVEN LEAD TIME: Estimated 4-12 week lead time to ship orders.

BOOTH & SMALL OVEN LEAD TIME: Estimated 3-6 week lead time to ship orders (this applies to orders containing only booths). However, if a booth and oven are ordered together, they will be shipped at the same time. Systems can be shipped separately upon customer request. Additional shipping charges may apply.

SHIPPING: Shipping cost is not calculated online. Customers placing equipment orders online will be contacted by a sales associate with a shipping quote. Quote costs are only an estimation, as freight prices may change by the time of shipping. All assembled ovens and larger unassembled ovens will be shipped via commercial flatbed trucks and will be side-loaded.

DELIVERY: Customer/Buyer must have a forklift on-site to unload equipment the day it arrives. It is recommended to have a forklift with at least 60" forks and the ability to lift 5000-6000 lbs. Assembled ovens have fork slots built into the top / side of the oven. If the driver has to wait more than 30 minutes to unload, a charge of \$75 per 30 minutes will incur until equipment is unloaded. All electrical and gas hook-ups, along with any codes/specs, are the responsibility of the buyer/customer. If the shipment arrives damaged from transit, the customer will be responsible for writing "DAMAGED" on the bill of lading before signing for the shipment, or the shipment should be refused.

Please review all information on your quote for accuracy such as ship to address, products and any notations. Write any changes on your order and then sign, date, and return the estimate it to our office with down payment.
